(Brief record of the Proceedings of Sikkim Legislative Assembly held on Friday 18th March, 2016)

The Fourth Session (Budget Session 2016-2017) of Ninth Sikkim Legislative Assembly continued for its second day today at 11:00 a.m. in the Assembly Hall, Gangtok.

Hon'ble Speaker Shri K.N.Rai presided over the House.

All the Hon'ble Members were present.

QUESTION HOUR

1. Before taking up Question Hour, the Hon'ble Speaker informed the House that the Assembly Secretariat had received a total of 30 Notices of Questions from three Hon'ble Members. Out of which, 15 numbers of Questions were admitted for Oral Answers and 15 numbers of Questions were admitted for Written Answers.

The Hon'ble Speaker further informed the House that only two Supplementary Questions were allowed, one to the Mover of the Question and One Supplementary Question to any other Hon'ble Members. The Supplementary Questions should be precise and to the point and should be related to the subject matter of the main Question only.

Thereafter, the Questions of the following Hon'ble Members as listed in the List of Business of the day were taken up for Oral answers:

Thereafter the House was adjourned at 12:20 pm for Tea break and reassembled at 12:40 pm with the Hon'ble Speaker in the Chair.

LEGISLATIVE BUSINESS
