(Brief record of the Proceedings of Sikkim Legislative Assembly held on Saturday 26th March, 2016)

The Fourth Session (Budget Session 2016-2017) of Ninth Sikkim Legislative Assembly continued for its seventh day today at 11:00 a.m. in the Assembly Hall, Gangtok.

Hon'ble Deputy Speaker Shri Sonam Gyatso Lepcha presided over the House.

All the Hon'ble Members except Shri Pintso Chopel Lepcha were present.

LEAVE OF ABSENCE

1. Before taking up the Business of the House, the Hon'ble Deputy Speaker informed the House that Hon'ble Member Shri Pintso Chopel Lepcha had applied for leave of the House to remain absent from the House today. Accordingly the leave was considered and granted.

LEGISLATIVE BUSINESS
(Introduction of Bill)

2. Hon'ble Minister-in-Charge for Forest, Environment & Wildlife Management Department moved for Leave of the House to introduce *the Sikkim Ecology Fund and Environment Cess (Amendment) Bill, Bill No. 5 of 2016.*

The Hon'ble Speaker informed the House that discussion and voting on the Bill would be taken up on 28th March, 2016.

FINANCIAL BUSINESS

(Discussion and Voting On Separate Demands for Grants)

3. On being called upon by the Hon'ble Deputy Speaker, the Hon'ble Minister-in-Charge for **Human Resource Development, Sports & Youth Affairs, Law, Legislative and Parliamentary Departments** presented the Demands for Grants under his charge for Discussion and Voting of the House.
