(Brief record of the Proceedings of Sikkim Legislative Assembly held on Tuesday 6th March, 2018)

The Seventh Session (Budget Session 2018-2019) of Ninth Sikkim Legislative Assembly commenced today at 11:00 a.m. in the Assembly Hall, Gangtok.

Hon'ble Speaker Shri K.N. Rai presided over the House.

All the Hon'ble Members were present.

THE HON'BLE GOVERNOR'S ADDRESS

1. Hon'ble Governor of Sikkim, Shri Shriniwas Patil arrived at 11:00 a.m. to address the House. He was received by the Hon'ble Speaker, Shri K.N. Rai and conducted to the House in the prescribed procession.

When the Governor reached the dais, the **National Anthem** was played. The Hon'ble Governor then addressed the House and after conclusion of the address, the **National Anthem** was played again. The Hon'ble Governor then left the Hall according to the procession.

REPORT ON ADDRESS

2. Hon'ble Speaker Shri K.N. Rai informed the House that as required under Article 176(1) of the Constitution of India, the Hon'ble Governor of Sikkim has delivered his address to the House and copies of the address has been laid on the Table of the House.

MOTION OF THANKS

3. On being called upon by the Hon'ble Speaker, Shri Pawan Chamling, Hon'ble Chief Minister also the Leader of the House moved the following Motion of Thanks on Hon'ble Governor's Address.

"That the Members of Sikkim Legislative Assembly assembled in this Session are deeply grateful to the Hon'ble Governor of Sikkim for his Address which he has been pleased to deliver today, the 6th March, 2018".

Hon'ble Minister Shri R.B Subba seconded the Motion of Thanks on the Hon'ble Governor's Address.

The Hon'ble Speaker then informed the House that Discussion and Voting on Motion of Thanks on the Hon'ble Governor's address would be taken up tomorrow, the 7th March, 2018.

LEGISLATIVE BUSINESS

(Introduction of Bill)

4. Smt. Tulshi Devi Rai, Hon'ble Minister in Charge of Water Security and Public Health Engineering Department, Government of Sikkim moved for leave of the House to introduce *the Sikkim Water Supply and Water Charges (Amendment) Bill, Bill No. 4 of 2018*. Leave was granted and the Bill was introduced accordingly.

The Hon'ble Speaker informed the House that Discussion and Voting on the Bill would be taken up day after tomorrow, the 8th March 2018.

Thereafter, the House adjourned at 12.25 pm for lunch break and reassembled at 2.00 p.m with the Hon'ble Deputy Speaker in the Chair.

FINANCIAL BUSINESS

Presentation of General Budget 2018-19

(Budget First Stage)

5. Shri Pawan Chamling, Hon'ble Chief Minister in Charge for Finance, Revenue and Expenditure Department, Government of Sikkim presented the Estimates of Receipts, Annual Financial Statement, Demands for Grants and Explanatory Memorandum to the Annual Budget 2018-19.
