All the Hon'ble Members except Hon'ble Members Sarvashri Gopal Barailey, Sonam Lama, K.N. Lepcha, R.N. Chamling and Mechung Bhutia were present in the House.

The Chair informed the House that the Session is being re-convened to consider urgent Government business including Vote on Account for the year 2019-20 under the Provision of Rule 16 of the Rules of Procedure and Conduct of Business in Sikkim Legislative Assembly.

1. Before taking up the Business of the House, the Hon'ble Speaker informed the House that Hon'ble Members Sarvashri Gopal Barailey and Mechung Bhutia had applied for leave of the House to remain absent from the House. Accordingly, the leave was considered and granted.

2. The Hon'ble Speaker made obituary reference to the passing away of Shri C.B. Rai former MLA of Sikkim Legislative Assembly. He also made reference to the martyred soldiers, who lost their precious life in the recent terrorist attack on the CRF convoy at Avantipura in Pulwama district of Jammu on Thursday, 14th February, 2019.

Hon'ble Leader of the House Shri Pawan Chamling and Hon'ble Minister R.B. Subba also made Obituary References on the passing away of late Shri C.B. Rai former MLA of Sikkim Legislative Assembly. In addition, the Hon'ble Leader of the House also paid homage to the martyred soldiers who sacrificed their lives in the recent terror attack in Jammu.

Thereafter, the House observed two minutes silence as mark of respect for the departed souls.

Vote on Account 2019-20


