(Brief record of the Proceedings of Sikkim Legislative Assembly held on Wednesday 24th May, 2017)

The Sixth Session (Part-II) of the Ninth Sikkim Legislative Assembly commenced today at 11:00 a.m. in the Assembly Hall, Gangtok.

Hon'ble Speaker, Shri K.N. Rai presided over the House.

All the Hon'ble Members except the Hon'ble Ministers, Sarvashri S.B.Subedi, Tshering Wangdi Lepcha and Hon'ble Member, Shri Rup Narayan Chamling were present.

OATH OR AFFIRMATION ADMINISTERED

1. Shri K.N.Rai, Hon'ble Speaker administered Oath or Affirmation to Shri D.R.Thapa, Hon'ble Member, recently elected in a bye election from 28-Upper Burtuk Assembly Constituency as required under Rule 5 of the Rules of Procedure and Conduct of Business in the Sikkim Legislative Assembly.

LEAVE OF ABSENCE

Before taking up the Business of the day, the Hon'ble Speaker informed the House that Hon'ble Ministers, Sarvashri Sher Bahadur Subedi, Tshering Wangdi Lepcha and Hon'ble Member, Shri Rup Narayan Chamling applied for leave of the House to remain absent for two days i.e. on 24th & 25th May, 2017 which was granted accordingly.
