(Brief record of the Proceedings of Sikkim Legislative Assembly held on Monday 29<sup>th</sup> January, 2018)

The Sixth Session (Part IV) of Ninth Sikkim Legislative Assembly commenced today at 11:00 a.m. in the Assembly Hall, Gangtok.

The Hon'ble Deputy Speaker, Shri Sonam Gyatso Lepcha presided over the House.

All the Hon'ble Members except Hon'ble Minister Shri D.T. Lepcha and Hon'ble Member Shri Kunga Nima Lepcha were present.

**OBITUARY REFERENCE**

1. The Hon'ble Deputy Speaker made Obituary Reference on the passing away of Late T.V. Rajeswar, the former Governor of Sikkim.

The Chief Minister also the Hon'ble Leader of the House paid rich tribute to the departed soul.

Thereafter, the House observed silence for a while.

**LEAVE OF ABSENCE**

2. The Hon'ble Deputy Speaker informed the House that the Hon'ble Member Shri Kunga Nima Lepcha had applied for leave of the House to remain absent for today i.e. on 29<sup>th</sup> January 2018.

Accordingly the leave was considered and granted

## LEGISLATIVE BUSINESS

### QUESTION HOUR

3. Before taking up the Question Hour, the Hon'ble Deputy Speaker informed the House that the Assembly Secretariat had received a total of 20 Notices of Questions from Hon'ble Members, Sharvashri Kunga Nima Lepcha and Shri Rup Narayan Chamling. Out of which, 11 Questions were admitted for Oral Answer and 9 Questions were admitted for Written Answer.

The Hon'ble Deputy Speaker also informed to the House that owing to Leave of absence applied by the Hon'ble Member, Shri Kunga Nima Lepcha, the Starred Questions to be asked by him on today have been placed on the Table of the House.

The Hon'ble Deputy Speaker further informed the House that only two Supplementary Questions shall be allowed, one to the Mover of the Question and one Supplementary Question to other Hon'ble Member. The Supplementary Questions is to be precise and should relate to the subject matter of the main Question only.

Thereafter, the Starred Question No. 3, 4 & 8 of the Hon'ble Member Shri Rup Narayan Chamling as listed in the List of Business of the day were taken up for Oral Answer:

The Hon'ble Member, Shri Rup Narayan Chamling raised one each Supplementary Question of the main Question.

The Minister concerned replied to these Questions raised by the Hon'ble Member.

The Hon'ble Deputy Speaker then informed the House that the Written answers to the Unstarred Question No. 1 & 7 of Hon'ble Member Shri Rup Narayan Chamling and Question No. 5, 6 & 8 of Hon'ble Member Shri Kunga Nima Lepcha were placed on the Table of the House.

## LEGISLATIVE BUSINESS

(Withdrawn of Bill)

4. Under the Provision of *Rule 104 (a) of the Rules of Procedure and Conduct of Business in Sikkim Legislative Assembly*, Shri Somnath Poudyal, the Hon'ble Minister-in-Charge of Horticulture & Cash Crops Development Department, Government of Sikkim moved for leave of the House to withdraw *the Sikkim Non Organic Agricultural and Horticultural Commodities (Prohibition and Regulatory) Bill, Bill No. 2 of 2018* on technical ground.

Accordingly the Motion was adopted and the Hon'ble Deputy Speaker informed the House that the Bill stood withdrawn in the House.

## FINANCIAL BUSINESS

(SECOND SUPPLEMENTARY DEMANDS FOR GRANTS)

5. Shri Pawan Chamling, Hon'ble Chief Minister also the Minister - in - Charge of Finance, Revenue and Expenditure Department, Government of Sikkim presented *the Second Supplementary Demands for Grants* for the year 2017-2018.


The Hon'ble Deputy Speaker informed the House that Discussion and Voting on the Second Supplementary Demands for Grants 2017-2018 would be taken up tomorrow, the 30<sup>th</sup> January, 2018.
